Susan is a nationally recognized immigration lawyer. As Chair of Mintz's Immigration Practice, she works with corporate clients to address their immigration challenges. Susan is very active in the American Immigration Lawyers Association (AILA) and has contributed to federal and state immigration regulations. She is frequently quoted in the media. She is also an editor of Mintz's Immigration Law blog and has been recognized as a "Top Author" by JD Supra. Susan helped to lead a Mintz team that worked with the ACLU of Massachusetts and others to obtain a temporary restraining order on the 2017 Travel Ban. Through her pro bono work, she has helped many immigrants obtain asylum.

Recognized nationally and internationally as one of the most highly regarded immigration lawyers in the legal profession and the recipient of dozens of awards by prominent organizations, Susan Cohen brings more than 30 years of experience and a deep well of knowledge to her practice.

With her team of 35 attorneys, specialists, and assistants in the Mintz immigration department she founded and chairs, Susan collaborates with corporate and individual clients to address the array of immigration challenges they encounter every day. She helps companies navigate around immigration obstacles, enabling them to bring in the creative international talent they need, grow their market share by seizing opportunities, and do what they do best: run their businesses, provide good jobs, and enhance their communities.

Susan closely monitors proposed modifications to the ever-evolving regulatory framework governing immigration. This enables her to foresee changes coming, prepare for them, and then move quickly to advise and protect her clients when measures and decisions by the executive branch, Congress, or the judiciary alter the immigration landscape.

Active in the American Immigration Lawyers Association (AILA), Susan often plays an instrumental role in shaping federal and state regulations and other government activity. For example, in 2020 she led a Mintz team that represented hundreds of thousands of foreign students in litigation which overturned U.S. Immigration and Customs Enforcement's controversial and dangerous COVID-related student visa policy and in 2017 she helped lead a Mintz team that worked with the American Civil Liberties Union of Massachusetts and others to obtain a temporary restraining order on the 2017 Travel Ban. She also contributed significant input into such legislation as:

- The US Citizenship and Immigration Services regulations implementing the Immigration Act of 1990;
- Department of Labor (DOL) regulations implementing changes to the H-1 B visa category as a result of the American Competitiveness and Workforce Improvement Act of 1998;
- DOL labor certification regulations (PERM) issued in 2004.

Susan also advised the Commonwealth of Massachusetts in drafting the legislation that resulted in the Massachusetts Global Entrepreneur in Residence program.

Taking a lead in the firm's steadfast commitment to community service and pro bono work, Susan has helped many immigrants obtain asylum. Often this requires her to collaborate closely with asylum candidates to gather and organize voluminous evidence for their cases; reach out to government officials and others with whom she has cultivated strong working relationships; and use her strong persuasive communications skills to craft airtight cases to present to judges and other immigration decision makers.

Susan has won awards for her political asylum work from the Supreme Judicial Court of Massachusetts, the Rian Immigrant Center, the Political Asylum/Immigration Representation Project, the Massachusetts Lawyers Weekly, and Mintz.

Frequently quoted in the <u>media</u>, Susan also accepts many invitations to speak to a variety of audiences at public events. She regularly writes on immigration law topics and serves on the Editorial Board of *Law360*. She also serves as an editor of Mintz's Immigration Law blog and has been recognized as a "Top Author" by *JD Supra*.
